## INFORMATION ON THE PROCESSING OF PERSONAL DATA

**METHODS AND PURPOSE OF DATA PROCESSING.** We inform you that your data will be processed using the following paper-based, IT and/or telematic means with the following purposes:

**LEGAL BASIS** The provision of data is mandatory for everything required by legal and contractual obligations and therefore any refusal to provide them in whole or in part may result in the impossibility of providing the requested services. **RECIPIENT CATEGORIES** Subject to communications made in fulfillment of legal and contractual obligations, all data collected and processed may be communicated exclusively for the purposes specified above to the following categories of interested parties:

- Entities, companies or individuals who have relationships with the A.S.D. Academy for the organization, management, advertising or sponsorship of events, tournaments and sporting events;
- Entities or companies that carry out activities such as insurance companies affiliated with the Association or health-related activities in service of the A.S.D. Academy or connected to the aforementioned insurance companies;
- Subjects who carry out data processing activities on behalf of the A.S.D. Academy;
- Entities, Companies or Subjects that carry out commercial, promotional and advertising activities.

**STORAGE PERIOD** The mandatory data for contractual and accounting purposes are kept for the time necessary to execute the commercial and accounting relationship. The data of parties who do not make use of the services, despite having had previous contact with company representatives, will be immediately deleted or processed anonymously if their conservation is not otherwise justified.

**RIGHTS OF THE INTERESTED PARTY** Pursuant to the European Regulation 679/2016 (GDPR) and national legislation, the interested party may, by contacting the Data Controller, exercise the following rights, according to the methods and within the limits established by current legislation:

- Request confirmation of the existence of personal data concerning him/her (right of access), know its origin and receive intelligible communication as well as access to information about the logic, methods and purposes of its treatment;
- Request the update of, correction, integration, cancellation, transformation into anonymous form, blocking of data processed in violation of the law, including those no longer necessary for the purposes for which they were collected;
- In cases of consent-based processing, receive your data provided to the owner, in a structured and readable form by a data processor and in a format commonly used by an electronic device;
- Submit a complaint to the supervisory authority.
